**What is the purpose of this research?**

**How long will I take part in this research?**

- At baseline: (a) a survey of infrastructure and AWC staff; (b) a survey of child anthropometrics and child assessments.
- During the school year: (a) a survey of AWW effort, monitoring, and satisfaction; (b) a classroom observation protocol; and (c) a survey of child anthropometrics.
- At each follow-up: (a) a survey of child anthropometrics

We will administer the aforementioned surveys at each *anganwadi* centre over the course of one day on each round of data collection.

**What can I expect if I take part in this research?**

As a participant, your *anganwadi* centre will be visited up to two times to administer the aforementioned surveys.

**What are the risks and possible discomforts?**

We do not foresee any potential risks (psychological, physical, social, legal, or other) for study participants.
